## Observed Clinical Encounter

It is expected trainees will regularly perform structured examination under observation of another trainee or fellow with the goal of improving clinical skills. Most trainees will undertake hundreds of cases prior to completion of training. Trainees are required to satisfactorily complete at least eight formal Observed Clinical Encounters, submitting at least two during each six months of core ICU training. Observed Clinical Encounters are clinical cases assessed by a fellow of the College of Intensive Care Medicine. Each should take approximately 20 minutes plus time for appropriate feedback. Submitted cases should focus on different organ systems and illnesses. One case should be an extramural consult or MET.

## **Performance Indicators for Items**

### **Patient Interviewing skills**

- Asks open questions and focus when appropriate
- Listens to answers and explore relevant issues
- Identifies and responds to non-verbal cues
- Adapts interview to situational context

### **Clinical Examination skills**

- Ability to conduct a structured, systematic examination
- Explains examination to the patient
- Detects relevant findings and focuses appropriately
- Observes and identifies relevant clues in the patient environment (bedside survey)
- Is aware of & appropriately interprets information from patient examination and associated monitoring devices

### **Communication skills**

- Listens to introduction / stem and focuses appropriately
- Presents in a clear and organised fashion

### **Diagnostic reasoning / management plan**

- Ability to weigh findings and explain potentially conflicting data
- Determines appropriate investigation
- Formulates accurate and weighted differential diagnosis
- Presents appropriate initial management plan, relevant to the patients situation
- Adequately justifies decisions & demonstrates understanding of risks and benefits
- Interprets additional data presented correctly
- Reformulates diagnostic algorithm and management plan based on additional data and in context of the patient
- Demonstrates knowledge and understanding relevant to the case

### **Organisation/efficiency**

- Uses time effectively and efficiently

### **Professional behaviour**

- Shows respect for the patient & family at all times
- Demonstrates awareness of potentially embarrassing or painful components of the examination
- demonstrates sensitivity to cultural and individual differences
- works collaboratively and respectfully with other staff
- Implements appropriate infection control practices
- Demonstrates respect, compassion and empathy
- Respects autonomy, dignity, confidentiality, privacy and diversity
