Additional notes

- PhD must be certified passed at the time of application and be awarded by an Australian or NZ University or Clinical School of more than 50 students or an overseas university in the THES top 200 universities;
- An education resource is a text, media and other digital asset that is used for acquiring knowledge, teaching, sharing knowledge, as well as for research purposes eg FOAMed.
- Published papers must be published or in press and must have been published in the past five years;
- Presentations may include poster and oral presentations;
- Audits must be the work of the applicant and must have been presented at a Departmental Quality Assurance Meeting;
- Documentary evidence is required for each of the above in the form of a published article, an acceptance letter from an editor, a conference program or in the case of an audit a letter from the Department Head stating that you were the principle author of the audit and that it was presented at a Departmental QA Meeting.

Compulsory hospital meetings and courses will not be scored.

Working in a rural area is defined as having worked in a regional hospital with a population less than 100,000 for at least 12 months or a rural or regional ICU for six months. Documentary evidence of the above is required.

**SECTION 7: INDIGENOUS ORIGIN**

Indigenous origin with indigenous community involvement (7 points)

Indigenous origin can apply when the application is of Australian Aboriginal, Torres Strat Islander, Maori or Pacific Islander descent; OR identifies as a person of such heritage AND is accepted as such by the relevant indigenous community.
