Descriptions of levels of entrustment

Level 1	<p>Direct supervision The trainee requires direct observation from a clinical supervisor; prompting is required or the task/activity is performed collaboratively with the clinical supervisor as a coactivity.</p>
Level 2	<p>Proactive supervision The trainee requires the clinical supervisor to be in the clinical unit and physically available within minutes to provide assistance and consultation. Findings or decisions may require consultation.</p>
Level 3	<p>Responsive supervision The trainee requires the clinical supervisor to be in the hospital and available for consultation and assistance; this includes availability by telephone for advice. Findings or decisions may require consultation.</p>
Level 4	<p>Oversight The trainee requires the clinical supervisor to be readily contactable, but the clinical supervisor does not need to be in the hospital. The trainee may require consultation for complex cases, complications or unexpected issues.</p>
Level 5	<p>Independent* The trainee understands risks and performs tasks/activities safely. The trainee is able to provide supervision to and teach junior trainees.</p>

*Although the trainee is able to perform the task/activity independently, as a trainee of the CICM training program the clinical supervisor must assume overall responsibility for the trainee at all times.

<p>Carries out meeting effectively</p> <ul style="list-style-type: none">• Makes appropriate introductions• Displays appropriate goal setting at start of meeting (<i>'I wanted to meet with you today to'</i>)• Gives family time to speak and demonstrates advanced listening skills• Changes course of discussion as required in response to family reactions• Paces discussion with appropriate use of pauses and silence• Recognises opportunities for empathy and displays empathetic responses• Appropriately interprets and answers questions• Chooses language appropriate to audience, avoids jargon		
<p>Appropriate professional behaviour</p> <ul style="list-style-type: none">• Demonstrates sensitivity and respect for patient/family/whānau and colleagues• Maintains patient dignity, privacy and confidentiality• Demonstrates culturally safe behaviours
