Description

Intensive care trainees will undertake medical terms at various points in their training, hence will have variable knowledge and clinical skills. It is expected that at the end of the medical term an intensive care trainee will be able to undertake an appropriate assessment and initial management common medical illness problems under indirect / remote supervision, as would be expected for a Basic level medical registrar. The intensive care trainee is not expected to function completely independently or manage complicated medical illness without direct assistance.

Feedback linked to assessment criteria during training is key to assisting trainees to learn and change their performance.
